2.	I understand that receipt of materials must be during the timeframe outlined in the approved permit at the designated facility.
3.	I agree to receive the Materials from the RDKS "as is" and acknowledge that the RDKS does not make any warranty or representation, express or implied, with regards to the state, condition, fitness or suitability for any purpose of any of the Materials;
4.	I agree to pay any associated fees with regards to the responsible disposal or return of the Materials;
5.	I HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE the RDKS and its employees, council members, officials and officers (the "Releasees") from all claims, demands, costs, expenses, actions and causes of action in respect of death, injury, loss or damage to my person or property however caused, arising or that may to arise by reason of my participation in the Program or the use of any Materials provided by the RDKS as part of the Program; and
6.	I FURTHER AGREE TO INDEMNIFY AND SAVE HARMLESS the Releasees for injury, death, property damage or any other loss sustained by a third party as a result of my participation in the Program or use of the Materials provided by the RDKS as part of the Program.
