REGIONAL DISTRICT OF KITIMAT-STIKINE Bylaw No. 347

A bylaw to establish a local service within a portion of Electoral Area E to provide increased capacity in the Queensway Sewer System for the benefit and future use of the local service area.

WHEREAS a regional district may, by bylaw, establish and operate a local service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Regional Board of the Regional District of Kitimat-Stikine has been requested to establish a local service for the purpose of providing increased capacity in the Queensway Sewer System for the benefit and future use of a portion of Electoral Area E;

AND WHEREAS the Regional Board has received a sufficient petition under Section 801 of the Municipal Act requesting the establishment of the local service and has waived the assent requirement;

AND WHEREAS the Director of Electoral Area E has consented, in writing, to the adoption of this bylaw;

NOW THEREFORE, the Regional Board of the Regional District of Kitimat-Stikine, in open meeting assembled, enacts as follows:

Service Being Established

- 1. "The service established under this Bylaw is for the following purposes:
 - (a) providing increased capacity in the Queensway Sewer System for the benefit and future use of the service area;
 - (b) collection, conveyance, treatment and disposal of sewage in the service area." (Amended by Bylaw No. 654, 2015)

Service Area Boundaries


- 2. The boundaries of the service area shall include a portion of Electoral Area E as shown outlined on the map attached hereto as Schedule A and forming part of this bylaw.
- 3. "The service area shall be known as "Thornhill Core Sewer System Service Area", and the service shall be known as the "Thornhill Core Sewer System Service"."

Cost Recovery

- 4. "As provided in section 378 of the *Local Government Act*, the annual cost of providing the Service shall be recovered by one or more of the following:
 - (a) property value taxes imposed on land only in accordance with Division 3 of Part 11 of the *Local Government Act*;
 - (b) fees and charges imposed under section 397 of the Local Government Act;
- (c) revenues received by way of agreement, enterprise, gift, grant or otherwise." (Amended by Bylaw No. 654, 2015/Bylaw No. 679, 2016)

Requisition Limit

- 5. "In accordance with section 339(1)(e) of the *Local Government Act*, the maximum amount that may be requisitioned annually for the cost of the Service is \$200,000.00." (Amended by Bylaw No. 654, 2015/Bylaw 679, 2016)
- 6. This bylaw may be cited as the "Thornhill Commercial Core Sewer System Local Service Establishment Bylaw No. 347, 1994".
